Electors should take note that the deadline for new applications to vote by post or to change existing postal or proxy arrangements e.g. cancellation or re-direction etc. must reach the Electoral Registration Officer at the address shown below by 5pm on 15 April 2019 if they are to be effective for this election.
7. New applications to vote by proxy must be received by the Electoral Registration Officer by 5pm on 24 April 2019.
8. The deadline for new applications to be received by the Electoral Registration Officer to vote by proxy on grounds of occupation, service or employment or a medical condition, illness or disability arising after 5pm on Wednesday 24 April 2019 is not later than 5pm on 2 May 2019.
