MINUTES OF MEETING

The minutes of the meeting of the Planning and Community Infrastructure Committee held on 23 January 2017 were confirmed and signed.

P76/16 Fenland District Council

The Clerk read to members a letter from Mr N Harding, the Head of Shared Planning at Fenland District Council (and Peterborough City Council), regarding the proposal of Fenland District Council to introduce, with effect from 1 July 2017, changes to that council's arrangements for consultation with Town and Parish Councils on planning applications.

The change to the consultation arrangement, the stated purpose of which is to reduce costs, is that FDC would no longer send to Town and Parish Councils paper copies of the planning applications and supporting documentation (including site plans) but would, instead, send to the local council from which a consultation response is being invited an e-mail notification of each planning application; it would then be a matter for the local council to decide how its members would access the documentation which would be available on the District Council's website – this could simply be viewed on-line or downloaded and printed by the consultee council.

Members decided that the situation be noted.

P77/16 Cambridgeshire County Council

The Clerk reported that there were no planning-related issues in terms of Cambridgeshire County Council schemes, projects, services or policies requiring consideration by this committee.

Members decided that the situation be noted.

P78/16 Roundabout at the junction of the A47 and A1101

Councillor Schooling had requested that an item of business be placed on the agenda for this meeting under which he could raise his concerns regarding highway safety on the approaches to the roundabout which is situated at the junction of the A47 and the A1101 (in the vicinity of Elme Hall Hotel).

Members decided that, given the absence of Councillor Schooling from the meeting and the fact that this roundabout does not fall within the geographical area covered by Wisbech Town Council – the site is actually within the County of Norfolk – there are no issues in this matter which require discussion by this committee.
